Sri Lanka State Trading (General) Corporation Limited, which is a fully Government owned self-financed Corporation operated under the Ministry of Trade, Commerce Food Security and co-operative Development, has been authorized by the Cabinet of Ministers to import up to five thousand two hundred metric tons (5,200) of Medium Grain Parboiled Nadu Rice depending on the market requirement. The Chairman, Ministry Procurement Committee (MPC) on behalf of the Secretary Ministry of Trade, Commerce Food Security and co-operative Development invites sealed bids from eligible and qualified bidders for the procurement of Medium Grain Parboiled Nadu Rice.

- 4. Qualification requirements of bidders include;
  - A. Minimum annual average turnover of USD two million or equivalent within the last three years. (i.e. 2021/22, 2022/23 and 2023/24)
  - B. Minimum 5 years of experience in exporting rice
  - C. The bidder should have completed at least one export order not less than 5,000 MT of rice within the last 3 years.
  - D. The Certificate of Origin issued by the Trade and Development Authority or a relevant authorized institute of the country of origin should certify that the items quoted are genuinely of the specified country's origin.
- 5. Colombo. Late Bids shall not be accepted.

- 6. Bids will be closed soon after above mentioned time (05<sup>th</sup> December 2024 11.30 a.m. Colombo) and opened immediately in the presence of the Bidders' authorized representatives who chose to attend.
- 7. All Bids must be accompanied by a Bid Security **irrevocable and unconditionally** encashable equal to 1% of Bid value in USD valid up to 25<sup>th</sup> January 2025

The name and identification number of this procurement are specified in the Bid document. The name, identification, and number of lots (individual contracts), if any, are provided in the Bid.

If the Purchaser found any unethical practices as stipulated under ITB Clause 3.2, the Purchaser will reject a bid, if it is found that a Bidder directly or through an agent, engaged in corrupt, fraudulent, collusive or coercive practices in competing for the Contract in question.

- 4.1 All bidders shall possess legal rights to supply the Goods under this Contract.
  - 4.2 A Bidder shall not have a conflict of interest. All bidders found to have conflict of interest shall be disqualified. Bidders may be considered to have a conflict of interest with one or more parties in this bidding process, if they:
    - a) are or have been associated in the past, with a firm or any of its affiliates which have been engaged by the Purchaser to provide consulting services for the preparation of the design, specifications and other documents to be used for the procurement of the goods to be purchased under these Bidding Documents, or
    - b) Submit more than one bid in this bidding process. However, this does not limit the participation of subcontractors in more than one bid.
  - 4.3 A Bidder that is under a declaration of ineligibility by the National Procurement Agency (NPA), at the date of submission of bids or at the date of contract award, shall be disqualified.
  - 4.4 Foreign Bidder may submit a bid only if so stated in the BDS.
- 5. Eligible Goods And Services
  5.1 All goods supplied under this contract shall be complied with related applicable standards stipulated by the Sri Lanka Standards Institute (SLSI) or the specifications in the rice research institute in Bathalegoda Sri Lanka. In the absence of such standards, the Goods supplied shall be complied with other internationally accepted standards.

- 6.2 The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents Failure to furnish all information or documentation required by the Bidding Documents may result in the rejection of the bid.

7.	Clarification of Bidding Documents	7.1	A prospective Bidder requiring any clarification of the Tender Document including the restrictiveness of specifications shall Contact the Purchaser in writing at the Purchaser's address specified in the Bidding document. The Purchaser will respond in writing to any request for clarification, provided that such request is received prior to the deadline for submission of Tender. The Purchaser shall forward copies of its response to all those who have purchased the Bidding document, including a description of the inquiry but without identifying its source. Bid Documents as a result of a clarification, should the purchaser deemed it necessary to amend it shall do so following the procedure under ITB Clause 8.

- 14.1 The Bidder shall indicate on the Price Schedule the unit prices and total Bid prices of the goods it proposes to supply in U\$D under the Contract.
  - 14.2. Any discount offered against any single item in the price schedule shall be included in the unit price of the item. However, a Bidder wishes to offer a discount as a bidder may do so by indicating such amounts appropriately.
  - 14.3. If so indicated in ITB Sub-Clause 1.1, bids are being invited for individual contracts (lots) or for any combination of contracts (packages). Unless otherwise indicated in the Bid, prices quoted shall correspond to 100% of the items specified for each lot and to 100% of the quantities specified for each item of a lot. Bidders wishing to offer any price reduction (discount) for the award of more than one Contract shall specify the applicable price reduction separately.
  - 14.4. (i) Prices indicated on the Price Schedule shall include all duties and sales and other taxes already paid or payable by the Supplier;
    - a. On components and raw material used in the manufacture or assembly of goods quoted; or
    - b. On the previously imported goods of foreign origin.
    - (ii) However, VAT shall not be included in the price but shall be indicated separately.
    - (iii) The price for inland transportation, insurance and other related services to deliver the goods to their final destination;
    - (iv) The price of other incidental services.
  - 14.5. The Prices quoted by the Bidder shall be fixed during the Bidder's performance of the Contract and not subject to variation on any account. A bid submitted with an adjustable price quotation will be treated as non- responsive and rejected, pursuant to ITB Clause 31.
  - 14.6. All lots, if any and item must be listed and priced separately in the Price Schedules. If a Price Schedule shows item listed but not priced, their prices shall be assumed to be included in the prices of other items.
  - 15.1 Unless otherwise stated in Bidding documents, the Bidder shall quoted in Sri Lankan Rupees and payment shall be payable only in Sri Lanka Rupees.
- 16. Documents Establishing the Eligibility of the Bidder
   16.1 To establish their eligibility in accordance with ITB Clause 4, Bidders shall complete the Bid Submission Form, included in Section IV, Bidding Forms.

- 17. **Documents Establishing** 17.1 the and Related Services
- To establish the conformity of the Goods and Conformity of Related Services to the Bid Documents, the Bidder Goods shall furnish as part of its bid the documentary evidence that the goods conform to the technical specifications and standards specified in Section V, Schedule of Requirements.
- 17.2 The documentary evidence may be in the form of literature, drawings data and shall consist of a detailed item by item description or (given is Section V, 2 Technical Specifications) of the essential technical and performance characteristics of the Goods and Related Services, Related Services to the technical specifications; and if applicable, a statement of deviations and exceptions to the provisions of the Schedule of Requirements
- 17.3 The Bidder shall also furnish a list giving full particulars, including quantities, available sources and current prices of spare parts, special tools, etc., necessary for the proper and continuing functioning of the Goods during the period if specified in the BDS following commencement of the use of the goods by the Purchase.
- **Documents** 18.1 The documentary evidence of the Bidder's qualifications to perform **Establishing The** the contract if its bid is accepted shall establish to the Purchaser's **Qualifications of The** satisfaction: Bidder
  - a) A Bidder that does not manufacture or produce the Goods it offers to supply shall submit the Manufacturer's authorization using the form included in Section VIII, Bidding Forms to demonstrate that it has been duty authorized by the manufacturer or producer of the Goods to supply these Goods;
  - b) That, if required in the BDS, in case of a Bidder not doing business within Sri Lanka, the Bidder is or will be (if awarded the contract) represented by an agent in Sri Lanka equipped and able to carry out the Supplier's maintenance, repair and spare parts stocking obligations prescribed in the Conditions of Contract and/or Technical Specifications; and
  - That the Bidder meets each of the qualification criteria specified in c)Section III, Evaluation and Qualification Criteria.
- 19. Period of Validity of Bids 19.1 Bids shall remain valid until the date specified in the BDS. A bid valid for a shorter date shall be rejected by the Purchaser as none Responsive.
  - 19.2 In exceptional circumstances, prior to the expiration of the bid validity date, the Purchaser may request bidders to extend the period of validity of their bids. The request and the responses shall be made in writing. If a Bid Security is requested in accordance with ITB Clause 20, it shall also be extended for a corresponding period. A Bidder may refuse the request without forfeiting its Bid Security. A Bidder granting the request shall not be required or permitted to modify its bid.
- 20. 20.1 The Bidder shall furnish as part of its bid, a Bid Security, as specified in the Bid.
  - 20.2 The Bid Security shall be in the amount specified in the Bid and denominated in Sri Lanka Rupees, unless otherwise stated and shall:

**Bid Security** 

- a) At the bidder's option, be in the form of either a bank draft or a bank guarantee from a banking institution;
- b) Be issued by an institution acceptable to the Purchaser.
- c) Be substantially responsive in accordance with the form included in Section IV, Bidding Forms;
- d) Be payable promptly upon written demand by the Purchaser in case the conditions listed in ITB Clause 20.5 are invoked;
- e) Be submitted in its original form; copies will not be accepted;
- f) Remain valid for the period specified in the BDS.

Any bid not accompanied by a substantially responsive Bid Security in accordance with ITB Sub-Clause 20.1 and 20.2, may be rejected by the Purchaser as non-responsive.

The Bid Security of unsuccessful Bidders shall be returned as promptly as possible upon the successful Bidder's furnishing of the Performance Security pursuant to ITB Clause 43.

The Bid Security may be forfeited executed:

- a) If a Bidder withdraws its bid during the period of bid validity specified by the Bidder on the Bid Submission Form, except as provided in ITB Sub-Clause 19.2; or
- b) If a Bidder does not agreeing to correction of arithmetical errors in pursuant to ITB Sub-Clause 30.3
- c) If the successful Bidder fails to:
  - i. Sign the Contract in accordance with ITB Clause 42,
- ii. Furnish a Performance Security in accordance with ITB Clause 43.
- 21.1 The Bidder shall prepare one original of the documents comprising the bid as described in ITB Clause II and clearly mark it as "ORIGINAL" In addition, the Bidder shall submit a copy of the bid and clearly mark it as "COPY". In the event of any discrepancy between the original and the copy, the original shall prevail.
  - 21.2 The original and the Copy of the bid shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the Bidder.
  - 21.3 Any interlineations, erasures or overwriting shall be valid only if they are signed or initiated by the person signing the Bid.

		23.2	The Purchaser may, at its discretion, extend the dead line for the submission of bids by amending the Bid Documents in accordance with ITB Clause 8, in which case all rights and obligations of the Purchaser and Bidders previously subject to the deadline shall thereafter be subject to the deadline as extended.
24.	Late Bids	24.1	The Purchaser shall not consider any bid that arrives after the deadline for submission of bids in accordance with ITB Clause 23. Any bid received by the Purchaser after the deadline for submission of bids shall be declared late, rejected and returned unopened to the Bidder.
25.	Withdrawal and Modification of Bids	25.1	A Bidder may withdraw or modify its Bid after it has been submitted by sending a written notice in accordance with ITB Clause 22, duly signed by an authorized representative and shall include a copy of the authorization in accordance with ITB Sub-Clause 21.2, (except that no copies of the withdrawal notice are required). #### 26.1 The Purchaser shall conduct the bid opening in public at the address, date and time specified in the BDS.

- 26.2 First, envelopes marked "WITHDRAWAL" shall be opened and read out and the envelope with the corresponding bid may be opened at the discretion of the Purchaser. No bid withdrawal shall be permitted unless the corresponding withdrawal notice contains a valid authorization to request the withdrawal and is read out at bid opening. Envelopes marked "MODIFICATION" shall be opened and read out with the corresponding Bid. No Bid modification shall be permitted unless the corresponding modification notice contains a valid authorization to request the modification and is read out at Bid opening. Only envelopes that are opened and read out at Bid opening shall be considered further.
- All other envelopes shall be opened one at a time, reading out; the name of 26.3 the Bidder and whether there is a modification; the Bid Prices; including any discounts and alternative offers; the presence of a Bid Security if required; and any other details as the Purchaser may consider appropriate. Only discounts and alternative offers read out at Bid opening shall be considered for evaluation. No Bid shall be rejected at Bid opening except for late bids in accordance with ITB Sub -Clause 24.1.
- 26.4 The Purchaser shall prepare a record of the Bid opening that shall include, as a minimum; the name of the Bidder and whether there is a withdrawal or modification; the Bid Price, per lot if applicable, including any discounts and the presence or absence of a Bid Security. The bids that were opened shall be resealed in separate envelopes, promptly after the bid opening. The Bidders representatives who are present shall be requested to sign the attendance sheet. A copy of the record shall be distributed to all Bidders who submitted bids in time.

#### **Evaluation and Comparison of Bids**

- 27. Confidentiality 27.1 Information relating to the examination, evaluation comparison and Post-qualification (if applicable) of bids and recommendation of contract award, shall not be disclosed to bidders or any other persons not officially concerned with such process until publication of the Contract Award.
  - Any effort by a Bidder to influence the purchaser in the examination, 27.2 evaluation, comparison and post-qualification of the bids or contract award decisions may result in the rejection of its Bid.
  - 27.3 Notwithstanding ITB Sub-Clause 27.2, if any Bidder wishes to contact the Purchaser on any matter related to the bidding process, from the time of bid opening to the time of Contract Award, it should do so in writing.
  - 28.1 To assist in the examination, evaluation, comparison and post- qualification of the bids, the Purchaser may, at its discretion, request any Bidder for a clarification of its Bid. Any clarification submitted by a Bidder in respect to its Bid and that is not in response to a request by the Purchaser shall not be considered for the purpose of evaluation. The Purchaser's request for clarification and the response shall be in writing. No change in the prices or substance of the Bid shall be sought, offered or permitted except to confirm the correction of arithmetic errors discovered by the Purchaser in the Evaluation of the bids in accordance with ITB Clause 30.

- 29. **Responsiveness of Bids** 29.1
  - 1 The Purchaser's determination of a bid's responsiveness is to be based on the contents of the bid itself.
  - 29.2 A substantially responsive bid is one that conforms to all the terms, conditions and specifications of the Bid Documents without material deviation reservation or omission. A material deviation, reservation or omission is one that;

# 04.Shipping & Quality Terms

Rice Consignment has to be approved as "Fit for human Consumption "by Industrial Technology Institute (ITI) Test Lab or RRDI Bathalagoda Test Lab. or Quality tests conducted by Sri Lanka Customs or food Administration unit Ministry of Health and random sampling has to be qualified as "Fit for human Consumption"

#### Return Procedure

If any shipment quality is rejected, shipper needs to replace the consignment with new one and full container (FCL) will be returned and exported to origin country and expenses of such event to be borne by the shipper including shipping charges, delivery & statutory charges in the destination country before export being started.

In case of reporting of quality rejects beyond 1% required to be replaced by the shipper. Charges for the shipment including delivery, shipping & statutory charges in the origin and destination country has to be borne by the shipper for rejected consignments as combined or individual shipments.

#### Shipping Demurrages

Demurrages due to non-availability of shipping documents on time for clearance or banking procedure at the destination and or due to not issue release order by the shipping agent at the destination port to be borne by the shipper.
